

JurySelect – Terms and Conditions of Service

Agreement between User and Court of Public Opinion/JurySelect

Welcome to JurySelect.™ The JurySelect web app (the “Site”) is owned and operated by Court of Public Opinion, LLC (hereinafter “CoPO”) The Site is offered to you and is conditioned on your acceptance without modification of the terms, conditions and notices contained herein (the “Terms”). Your accessing the Site and/or use of JurySelect constitutes your agreement to all such Terms. Please read them carefully.

Work-Product:

User inputs into JurySelect shall be presumed to be the work product of an attorney User. User notes regarding individual Jurors, as well as individual rankings, are stored on the User’s equipment only, and are not received nor retained by JurySelect/CoPO. Any additional User inputs into JurySelect, such as Juror names, cities of residence and responses to initial demographic questions, can be saved to the User’s equipment and shall be stored (for emergency User retrieval) on JurySelect’s systems for no more than 30 days following the commencement of JurySelection in each corresponding trial. No User inputs into JurySelect will be sold to any other User or party. JurySelect reserves the right to disclose information as necessary to satisfy any applicable law, regulation, legal process or governmental request.

Juror Privacy and Communications:

Users agree not to use JurySelect to violate any applicable law, order or ethical requirement pertaining to Juror or Prospective Juror privacy, communications with Jurors or Prospective Jurors, and/or which prohibits unlawfully discriminatory conduct in JurySelection.

Courtroom Use:

Users agree not to use JurySelect in violation of any rule of court, local rule, or courtroom rule or order, including with respect to the use of electronic equipment and/or internet access within a courtroom or courthouse.

Your Account:

If you use the Site, you are responsible for maintaining the confidentiality of your account and password and for restricting access to your computer, and you agree to accept responsibility for all activities that occur under your account or password. You may not assign or otherwise transfer your account to any other person or entity. Persons who will mirror a User’s screen in any trial will be required to establish their own account, and then to use a unique code supplied to the User for that trial. You acknowledge that JurySelect, CoPO and their affiliates are not responsible for third party access to your account or inputs that result from theft or misappropriation of your account by any User you authorize to mirror your inputs.

Indemnification

Arbitration

In the event the parties are not able to resolve any dispute between them arising out of or concerning these Terms and Conditions, or any provisions hereof, whether in contract, tort or otherwise at law or in equity for damages or any other relief, then such dispute shall be resolved only by final and binding arbitration pursuant to the Federal Arbitration Act, conducted by a single neutral arbitrator and administered by the American Arbitration Association, or a similar arbitration service selected by the parties, in a location mutually agreed upon by the parties. The arbitrator's award shall be final, and judgment may be entered upon it in any court having jurisdiction. In the event that any legal or equitable action, proceeding or arbitration arises out of or concerns these Terms and Conditions, the prevailing party shall be entitled to recover its costs and reasonable attorney's fees. The parties agree to arbitrate all disputes and claims in regard to these Terms and Conditions or any disputes arising as a result of the Terms and Conditions, whether directly or indirectly, including Tort claims that are a result of these Terms and Conditions. The parties agree that the Federal Arbitration Act governs the interpretation and enforcement of this provision. The entire dispute, including the scope and enforceability of this arbitration provision shall be determined by the Arbitrator. This arbitration provision shall survive the termination or these Terms and Conditions.

Class Action Waiver

Any arbitration under these Terms and Conditions will place on an individual basis; class arbitrations and class/representative/collective actions are not permitted. THE PARTIES AGREE THAT A PARTY MAY BRING CLAIMS AGAINST THE OTHER ONLY IN EACH'S INDIVIDUAL CAPACITY, AND NOT AS A PLAINTIFF OR CLASS MEMBER IN ANY PUTATIVE CLASS, COLLECTIVE AND/OR REPRESENTATIVE PROCEEDING, SUCH AS IN THE FORM OF A PRIVATE ATTORNEY GENERAL ACTION AGAINST THE OTHER. Further, unless both you and JurySelect agree otherwise, the Arbitrator may not consolidate more than one person's claims, and may not otherwise preside over any form of a representative or class proceeding.
